

COMPETITION BASES " MONTHLY DRAW VIP AREA TICKETS"

FIRST.- REAL MADRID CLUB DE FUTBOL (hereafter "REAL MADRID") will carry out between the period of January 2018 and December 2018, both months included, a promotion called "**MONTHLY DRAW VIP AREA TICKETS**", under the moniker of a "free draw" for each of the (12) months.

In the event that in any of the twelve (12) aforementioned months there is no football or basketball competition, this promotion will not be held. In the event that there is only football competition or only basketball competition, the promotion will only take place in the competition that is active that specific month.

SECOND.- Anyone who meets the condition of being able to participate in each of the twelve (9) monthly draws of this promotion will have the right to participate. "**Real Madrid club members**" and "**Madridistas**" the last day of the month before the month of the competition, people over the age of fourteen (14) who are up to date with payment of anything owed. In the event that the match is held between the first ten (10) days of the following month, all the "**Real Madrid club members**" and "**Madridistas**" will be considered up until the fifteenth (15) of the month before.

THIRD.- The aim of this promotion is to reward Club members and Madridistas.

FOURTH.- Amongst all of the participants in the promotion, nine (9) prizes, will be given out, as follows:

- **Six (6) pairs of football tickets in the VIP Area of the Estadio Santiago Bernabéu.**
- **Three (3) pairs of basketball tickets in the VIP Area of the Palacio de los Deportes de la Comunidad de Madrid.**

The prizes only include the double tickets for either football or basketball stated in the paragraph above, not including any possible transport costs, overnight stays or any other costs the winners may face.

FIFTH.- The monthly draws will be carried out electronically by the Madrid Notary, D. Cruz-Gonzalo López-Muller Gómez, who has had witnessed the registering of the Bases, which cover all the people stated in the Second Base.

The draws will take place in the offices of the Estadio Santiago Bernabéu the second Thursday of each month, Real Madrid reserve the right to change this at their convenience.

In this competition, the draw will determine six (6) winners of the double football tickets for the VIP Area of the Santiago Bernabéu Stadium and three (3) winners of the basketball tickets in the VIP Area of the Palacio de los Deportes de la Comunidad de Madrid, as well as six (6) and six (6) substitute winners, respectively, who will substitute the winners in the cases of incomplete or incorrect identification, non-compliance with the requirements demanded in the provided rules or the impossibility of locating the winners seven (7) days from the date of the draw.

SIXTH.- REAL MADRID will contact the winners, by telephone or by any other means that are considered appropriate, the result of the draw and how and when the prize won can be collected.

To claim the prize won the winners must present their Club Member or Madridista card along with National Identity Card (*DNI*) or Family Register (*Libro de Familia*).

SEVENTH.- The prizes that are in this promotion are personal and non-transferable, and therefore they cannot under any circumstances be changed, altered or exchanged for cash compensation at the winner's request.

If the winners cannot attend the match corresponding to the tickets won, they will lose the right to the prize, and these cannot be exchanged to another game or transferred to third parties.

EIGHTH.- The Directors and employees of REAL MADRID or their direct family members, or the Directors or employees of intermediary companies cannot take part in the competition, be it directly or indirectly.

NINTH.- When taking part in this promotion, participants accept these Legal Bases and the REAL MADRID criteria in terms of resolving any issue derived from the draw.

TENTH.- Participants give express permission to REAL MADRID to use their name and image publically, in the case of being announced as winners, in any promotional material linked to the promotion.

ELEVENTH.- The voluntary providing of personal data requested to participate in this promotion means that the participant gives their consent so that REAL MADRID CLUB DE FÚTBOL, by its own means or through other entities that manage or process such data, treat them informally, for commercial purposes only, and may incorporate said data into an automated file, which will be used to communicate with the participant in the future. The participant will have the right to access said file in order to modify, correct or cancel, totally or partially, its content, only by requesting it in writing at the registered office of REAL MADRID CLUB DE FÚTBOL (Avda. de Concha Espina, 1, 28036 - MADRID). In the same way, given that the draw is done in front of a Notary, the participant agrees that their personal details will be given to the certifying Notary and that the data will then be used in a notarial act, which will prove the correct execution of the draw.

Responding to questions on said data is obligatory, failing to provide these answers means you cannot take part in the promotion and, consequently, in the prize draw itself.

TWELFTH.- If the winner is not of legal age, the permission of their parent or legal guardian or legal representative will be required so that they can take part in the promotion and potentially, acceptance of the prize.
