

**LEGAL TERMS FOR "TRAVEL TO THE HEART OF REAL MADRID"**  
**COMPETITION**

**FIRST.- REAL MADRID FOOTBALL CLUB** (hereinafter **REAL MADRID**) will carry out a promotion called "**TRAVEL TO THE HEART OF REAL MADRID**", under the modality of "free draw" to be celebrated on January 8, 2019.

**SECOND.-** All those persons who have been "**Holders of the International Madridista Card**" for at least one year and are up to date with the payment of their obligations and those "**Holders of the International Madridista Card**" who have subscribed to a membership before December 31, 2018, will have the right to participate in the promotion.

**THIRD.-** Among all the participants in the present promotion one (1) prize will be drawn, consisting of a weekend trip for two people to the city of Madrid which will include the following activities:

- Return tickets for two people from the place of residence
- Two nights stay in a hotel in Madrid
- Two tickets for a match at the Santiago Bernabéu Stadium
- A meal at the Real Café Bernabéu
- Tickets for the Bernabéu Tour

The activities included in the prize may vary depending on the sporting calendar of that weekend.

**FOURTH.-** The prize draw will be held, by random procedure, on February 8, 2019 before the Notary of Madrid, D. Cruz-Gonzalo López-Muller Gómez, before whom these legal terms have been deposited. Real Madrid reserves the right to modify at its convenience the said date.

For these purposes, prior to the conclusion of the draw, REAL MADRID will deliver to the Notary a list of all participants who have fulfilled all of the requirements in these legal terms.

**FIFTH.-** REAL MADRID will communicate to the winner, by telephone or by any other means deemed appropriate, the result of the draw and the means and date of claiming the prize obtained. REAL MADRID will send the winner an email with all the information relative to the prize, including a document requesting express consent for REAL MADRID to publicly use the winner's name and image, in any advertising material related to the promotion in question. If the winner agrees and gives their consent, they must return the signed document to REAL MADRID by email.

For the delivery of the prize obtained the presentation by the winner of their ID or Family Book will be necessary.

**SIXTH.-** The prizes that are the object of this promotion can't under any circumstances be subject to change, alteration or compensation in cash at the request of the winner.

**SEVENTH.**- Directors and employees, of REAL MADRID, of any kind, nor their immediate family members, employees and managers of the companies involved, directly or indirectly, in this promotion may not participate in this promotion.

**EIGHTH.**- The participants, by the mere fact of participating in the present promotion, accept the present rules and the criterion of REAL MADRID regarding the resolution of any issue derived from it, including the draw.

**NINTH.**- Participants expressly authorize REAL MADRID to use their name and image, in the event of being winners, in any publicity material related to this promotion.

**TENTH: TENTH.**- The entity responsible for handling your data is Real Madrid Club de Fútbol, Estadio Santiago Bernabéu, Avenida de Concha Espina, 1, 28036, Madrid. By voluntarily providing your personal data which is required to participate in this competition and draw, Real Madrid Club de Fútbol itself or through other entities who carry out the management and communication of data, will handle your data electronically, using it within this competition and draw and to communicate with you, the participant, in the future.

Responding to questions on said data is obligatory, failing to provide answers means you cannot take part in the promotion and, consequently, in the prize draw itself. Given that the draw takes place in the presence of a Notary, Real Madrid Club de Fútbol states that the personal data of participants may be passed onto the certifying Notary and that said data may be included in a notarial act to ensure the draw is carried out correctly.
