

LEGAL BASES FOR THE INTERNATIONAL MADRIDISTA PACK MONTHLY PRIZE DRAW

FIRST.- REAL MADRID CLUB DE FUTBOL (henceforth "Real Madrid") shall run a promotion entitled "**INTERNATIONAL MADRIDISTA PACK MONTHLY PRIZE DRAW**" between November 2017 and October 2018, both inclusive, under the category of "complimentary prize draws", to be held on each of the twelve (12) aforementioned months.

SECOND.- The twelve (12) monthly prize draws are open to all of those "Real Madrid members" living abroad, that is to say they are "International Madridistas" on the final day of the month previous to the staging of the prize draw in question and are up to date with their payments.

THIRD.- The aim of this promotion is to reward the loyalty shown by the club's "**International Madridistas**".

FOURTH.- From amongst all of the participants in this promotion, each month three (3) prizes will be drawn, consisting of a pack of "**Real Madrid Products**" composed of the following:

- A Madridista flag
- An official jersey
- A ball
- A scarf
- A hat

FIFTH.- The monthly draws shall be staged, using a computerised system, before the Madrid Notary Mr Cruz-Gonzalo López-Muller Gómez, who notarised these bases, which include all of the individuals who meet the criteria established in the Second basis.

The prize draws shall be conducted at the offices at the Santiago Bernabéu stadium on the second Thursday of each month. Real Madrid reserves the right to amend the date of the draw at its convenience.

SIXTH.- REAL MADRID shall contact the winners by telephone or by any other means it sees fit to inform them of the result of the draw and the means and date to collect their prize.

In order to receive their prize the winners will need to present their members' or Madridista cards and their DNI (National identity card) or their family book.

SEVENTH.- The prizes given out as part of this promotion are personal and non-transferable, and therefore can under no circumstance be changed, altered or exchanged for money at the request of the winner.

EIGHTH.- Employees and directors of REAL MADRID, direct family members of said employees and directors, employees and directors of intervening companies are not allowed to participate, in any way, be it directly or indirectly, in this competition.

NINTH.- Participants, by participating in this competition, accept these Terms and criteria from REAL MADRID with regard to resolving any issue arising from the competition, including the draw.

TENTH.- The participants expressly allow REAL MADRID to use their name and image for publicity purposes, if they are named as prize winners, in any publicity material related to this competition.

ELEVENTH.- The voluntary submission of personal details requested in order to participate in this promotion assumes that the participant consents to REAL MADRID CLUB DE FÚTBOL themselves, or other entities that manage and process their data, handling said details electronically for purely commercial purposes, allowing the details to be recorded in a computerised file which they will take responsibility for, in order to communicate with the participant in the future. The participant will have the right to access their data file in order to modify, correct or cancel it, completely or partially, through the submission of a written request sent to the head office of REAL MADRID CLUB DE FÚTBOL (Avda. de Concha Espina, 1, 28036 -MADRID). Response to questions about said details is obligatory, meaning that refusal to submit the information will make it impossible to participate in this promotion and, consequently in the related prize draw.

TWELTH.- If any of the winners is a minor, they must hold permission from their parents, guardian or legal representative in order to participate in the promotion and, where applicable, to accept the prize.
